This amendment ieplaces the bill and clarifies that the Department of Agriculture, Conservation and Forestry is authorized to contract with Preble Street Food Security Hub to help address food insecurity throughout the State The amendment also specifies that this contract between the department and Preble Street Food Security Hub is not subject to competitive bid requirements of the State Purchasing Agent The amendment also changes the date, from December 6, 2023 to March 1, 2024, the department is required to report on the distribution of the funds by Preble Street Food Security Hub
