COMMITTEE AMENDMENT "A" to H.P 1055, L D 1645, "An Act to Reduce Plastic Packaging Waste"

Amend the bill by striking out the title and substituting the following  
**'An Act to Prohibit the Sale of Polystyrene Foam Packing Peanuts in the State'**

Amend the bill by striking out everything after the enacting clause and inserting the following

**'Sec. 1. 38 MRSA §1617** is enacted to read

**§1617. Polystyrene foam packing peanuts**

**1. Definitions.** As used in this section, unless the context otherwise indicates, the following terms have the following meanings

**A "Polystyrene foam" has the same meaning as in section 1571, subsection 5.**

**B "Polystyrene foam packing peanuts" means loose fill material made of polystyrene foam that is used to protect items during shipping or other transportation.**

**2. Prohibition.** Beginning January 1, 2025, a person may not sell, offer for sale or distribute for sale in this State polystyrene foam packing peanuts

**3. Administration and enforcement; education and outreach services.** The department shall implement, administer and enforce this section. The department may enter into an agreement with a 3rd-party entity to provide education and outreach services to assist in the implementation of this section.

**4. Violations.** A person that violates subsection 2 is subject to penalties under section 349'

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively
