Initiative Provides funding for a 90% reimbursement rate for general assistance expenditures.



Fiscal Detail and Notes

This amendment removes the emergency clause from the bill and changes the General Fund appropriation to the Department of Health and Human Services in fiscal year 2023-24 only from \$8,515,716 to \$6,386,787. As amended, the bill continues to appropriate \$8,515,716 in subsequent years.
