1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 5 MRSA §1997** is enacted to read:

3 **§1997. State Names Authority**

4 The Chief Information Officer shall appoint the State Names Authority to serve within
5 the Office of Geographic Information Systems. The State Names Authority must be a
6 qualified person and serves as a liaison to the United States Department of the Interior,
7 United States Geological Survey, United States Board on Geographic Names and makes
8 recommendations for renaming Maine features.

9 **Sec. 2. 5 MRSA §1998** is enacted to read:

10 **§1998. State Names Advisory Board**

11 **1. Established.** The State Names Advisory Board, established by section 12004-I,
12 subsection 75-D, shall serve to advise the State Names Authority in making
13 recommendations for renaming Maine features under section 1997.

14 **2. Members.** The State Names Advisory Board consists of 7 members as follows:

15 A. The State Archivist;

16 B. The State Geologist;

17 C. One member who represents a federally recognized Indian nation, tribe or band in
18 the State, appointed by the President of the Senate;

19 D. One member with expertise in the study of cultural anthropology, appointed by the
20 President of the Senate;

21 E. One member who represents historically disinvested African American populations,
22 appointed by the Speaker of the House;

23 F. One member with expertise as a Maine historian, appointed by the Speaker of the
24 House; and

25 G. One member of the Permanent Commission on the Status of Racial, Indigenous and
26 Tribal Populations under section 25001, appointed by the Speaker of the House.

27 **3. Terms.** The members under subsection 2 serve 2-year terms and continue serving
28 until either reappointed or replaced. In case of the termination of a member's service during
29 that member's term, the appointing authority shall appoint a successor for the unexpired
30 term.

31 **Sec. 3. 5 MRSA §12004-I, sub-§75-D** is enacted to read:

32 **75-D.**
