1	Be it enacted by the People of the State of Maine as follows:
2	Sec. 1. 5 MRSA §1997 is enacted to read:
3	<u>§1997. State Names Authority</u>
4 5 6 7 8	<u>The Chief Information Officer shall appoint the State Names Authority to serve within</u> the Office of Geographic Information Systems. The State Names Authority must be a qualified person and serves as a liaison to the United States Department of the Interior, United States Geological Survey, United States Board on Geographic Names and makes recommendations for renaming Maine features.
9	Sec. 2. 5 MRSA §1998 is enacted to read:
10	§1998. State Names Advisory Board
11 12 13	1. Established. The State Names Advisory Board, established by section 12004-I, subsection 75-D, shall serve to advise the State Names Authority in making recommendations for renaming Maine features under section 1997.
14	2. Members. The State Names Advisory Board consists of 7 members as follows:
15	A. The State Archivist;
16	B. The State Geologist;
17 18	C. One member who represents a federally recognized Indian nation, tribe or band in the State, appointed by the President of the Senate;
19 20	D. One member with expertise in the study of cultural anthropology, appointed by the President of the Senate;
21 22	<u>E. One member who represents historically disinvested African American populations, appointed by the Speaker of the House;</u>
23 24	F. One member with expertise as a Maine historian, appointed by the Speaker of the House; and
25 26	<u>G. One member of the Permanent Commission on the Status of Racial, Indigenous and Tribal Populations under section 25001, appointed by the Speaker of the House.</u>
27 28 29 30	3. Terms. The members under subsection 2 serve 2-year terms and continue serving until either reappointed or replaced. In case of the termination of a member's service during that member's term, the appointing authority shall appoint a successor for the unexpired term.

36 37 38	Sec. 4. Staggered terms. Notwithstanding the Maine Revised Statutes, Title 5, section 1998, subsection 3, initial appointments to the State Names Advisory Board must be staggered as follows:

1 2	1. Of the members appointed by the President of the Senate, one member must be appointed for a one-year term and one member must be appointed for a 2-year term; and
3 4	2. Of the members appointed by the Speaker of the House, one member must be appointed for a one-year term and 2 members must be appointed for a 2-year term.
5	SUMMARY
6	This bill establishes the position of State Names Authority. The State Names Authority
7	is appointed by the Chief Information Officer within the executive branch and serves in the
8	Office of Information Technology, Office of Geographic Information Systems. The State
9	Names Authority is directed to serve as a liaison to the United States Department of the
10	Interior, United States Geological Survey, United States Board on Geographic Names and
11	make recommendations for renaming Maine features. The bill also establishes the State
12	Names Advisory Board to advise the State Names Authority in making those
13	recommendations.
