The Guilford-Sangerville Water District and the Guilford-Sangerville Sanitary District shall, in accordance with this section, sell, transfer and convey to the district by appropriate instruments of conveyance all of their plants, properties, assets, franchises, rights and privileges, including, without limitation, lands, buildings, waters, water rights, springs, wells, reservoirs, tanks, standpipes, mains, pumps, pipes, machinery, fixtures, hydrants, meters, services, tools, equipment, apparatus and appliances used or useful in supplying water for domestic, commercial, industrial and municipal purposes, in consideration of the assumption by the district of all of the outstanding debts, obligations and liabilities of the Guilford-Sangerville Water District and the Guilford-Sangerville Sanitary District including, without limitation, the assumption of any outstanding bonds, notes or evidences of indebtedness of the Guilford-Sangerville Water District and the Guilford-Sangerville Sanitary District including District that are due on or after the date of the transfer'

## SUMMARY

This amendment provides that the existing customers of the Guilford-Sangerville Water District in the Town of Parkman and the Town of Abbot are not a part of the territory of the Guilford-Sangerville Utilities District, but the district may continue to provide water services to those existing customers The amendment requires the Guilford-Sangerville Water District and the Guilford-Sangerville Sanitary District to sell the districts' assets to the Guilford-Sangerville Utilities District as a part of the formation of the Guilford-Sangerville Utilities District
