4 5 6	21. List of banned performance-enhancing substances. Develop and maintain a list of banned performance-enhancing substances in accordance with Title 20-A, section 6621; and
7 8	Sec. 2. 5 MRSA §20005, sub-§22, as enacted by PL 2019, c. 524, §12, is amended to read:
9 10 11 12 13 14	22. Certification of recovery residences. Establish by rule criteria for the certification of recovery residences. The criteria for the certification of recovery residences must be based on criteria for recovery residences developed by a nationally recognized organization that supports persons recovering from substance use disorder. Certification of a recovery residence pursuant to this subsection is voluntary. Rules adopted pursuant to this subsection are routine technical rules as defined in chapter 375, subchapter 2- A_{τ} ; and
15	Sec. 3. 5 MRSA §20005, sub-§23 is enacted to read:
16 17 18 19 20	23. Treatment centers. Establish 2 treatment centers for substance use disorder treatment. The treatment centers must have at least 10 beds each. At least 40% of the occupancy in the treatment centers must be made available to individuals who have coverage under the MaineCare program. A treatment center established pursuant to this subsection shall provide:
21 22 23	A. A receiving center that is open 24 hours per day, 7 days per week to provide substance use disorder treatment while a patient waits for access to a higher level of care;
24	B. Medically managed withdrawal services;
25 26	<u>C.</u> Access to medication to treat substance use disorder, including any medication approved by the United States Food and Drug Administration; and
27 28	D. Coordination with services after treatment, including but not limited to local recovery centers, hypodermic apparatus exchange programs and recovery residences.
29 30 31 32 33	No later than February 1, 2025 and annually thereafter, the department shall report to the joint standing committee of the Legislature having jurisdiction over health and human services matters on the number of people served, the types of services provided, the attempts made at community outreach and any recommendations relating to the services provided by the treatment centers.
34 35 36 37	Sec. 4. Request for proposals. No later than December 1, 2023, the Department of Health and Human Services shall award contracts pursuant to a request for proposals to establish and operate the treatment centers required pursuant to the Maine Revised Statutes, Title 5, section 20005, subsection 23.
