**'Sec. 2. Transfer from Department of Defense, Veterans and Emergency  
13 Management, Disaster Recovery Fund, Other Special Revenue Funds account.**

**Resolved:** That, notwithstanding any provision of law to the contrary, the State Controller  
15 shall transfer \$162,500 no later than June 1, 2025 from the Department of Defense,  
16 Veterans and Emergency Management, Disaster Recovery Fund, Other Special Revenue  
17 Funds account to the unappropriated surplus of the General Fund.'
