9	COMMITTEE AMENDMENT "A" to HP 1149, LD 1786, "An Act to Repeal and
10	Replace the Charter of the Boothbay-Boothbay Harbor Community School District"
11	Amend the bill in section 1 in c 156 in section 6 in the 4th to the 26th lines (page 2,
12	lines 8 to 30 in LD) by striking out the following ", except that the budget validation
13	referendum procedure may be discontinued only by a referendum vote called by the district
14	school committee and held on a date at least 10 years after the effective date of this Act or
15	by a written petition for its discontinuance filed with the district school committee by at
16	least 10% of the number of voters voting in the last gubernatorial election in the
17 18	municipalities of the community school district In either case, the referendum question submitted to the voters must be as follows "Do you wish to continue the budget validation
18	referendum of this Community School District for at least another 10 years?" The district
20	school committee shall place the question on the next scheduled warrant for a budget
21	validation referendum or an earlier one if determined appropriate by the district school
22	committee If this referendum passes, the budget validation referendum procedure may be
23	discontinued only by a referendum vote called by the district school committee and held
24	on a date at least 10 years after the date of the prior vote to continue the budget validation
25	or by a written petition for its discontinuance filed with the district school committee by at
26	least 10% of the number of voters voting in the last gubernatorial election in the
27	municipalities of the community school district If this referendum fails, that vote ends the
28	use of the budget validation referendum beginning with the following budget year and
29 20	prohibits its reconsideration for at least 3 years. At least 3 years after a vote that
30 31	discontinued the budget validation referendum, an article to reinstate the budget validation referendum procedure may be placed on the ballot by vote of the district school committee
31	or by petition as provided by state law, and if approved by the voters the budget validation
33	referendum may not be discontinued except after 10 years as provided in this section or by
34	voter petition as provided in this section"
35	Amend the bill by relettering or renumbering any nonconsecutive Part letter or section
36	number to read consecutively
