For the purposes of this subsection, "volunteer firefighter" has the same meaning as in Title 30-A, section 3151, subsection 4, "volunteer municipal emergency medical services person" means an emergency medical services person as defined in Title 32, section 83, subsection 12 who responds to emergency medical services calls from a municipality and who receives no compensation from the municipality other than injury and death benefits, and "volunteer municipal firefighter" has the same meaning as in Title 30-A, section 3151, subsection 5 '

#### Fiscal Detail and Notes

This amendment delays the effective date of the tax credit in the bill to tax years on or after January 1, 2025. The revenue loss is eliminated in fiscal year 2023-24 and reduced to \$9,500 in General Fund revenue and \$500 in Local Government Fund revenue in fiscal year 2024-25.
