SUMMARY

This amendment removes the requirement that the Department of Administrative and Financial Services reimburse residents of the State for passenger rail service directly. Instead, the amendment requires the department to reimburse the Northern New England Passenger Rail Authority for resident fares on passenger rail service within the State during the period from December 1, 2023 to December 31, 2023. The amendment also adds an appropriations and allocations section.
