The bureau shall submit a report on its review and evaluation to the Joint Standing Committee on Health Coverage, Insurance and Financial Services no later than February 1, 2024. In response to the review, the Joint Standing Committee on Health Coverage, Insurance and Financial Services may report out a bill based on the review to the Second Regular Session of the 131st Legislature. Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.
