1	Be it enacted by the People of the State of Maine as follows:
2	Sec. 1. 30-A MRSA §4766 is enacted to read:
3	<u>§4766. Emergency Housing Matching Grant Program</u>
4 5	<b>1. Definitions.</b> As used in this section, unless the context otherwise indicates, the following terms have the following meanings.
6 7 8 9	A. "By-name list" means a comprehensive list of every person experiencing homelessness in an area, updated in real time using information collected and shared with the person's consent, containing information about the person, including the person's name, homeless history, health and housing needs.
10 11	B. "Client" means a person receiving services from an emergency housing or shelter program.
12 13 14	C. "Emergency housing or shelter program" means any organization that operates a facility with the primary purpose of providing temporary shelter for persons experiencing homelessness.
15 16	D. "Housing first" means an approach to serving persons experiencing homelessness that:
17 18	(1) Recognizes that a person experiencing homelessness must first be able to access a decent, safe place to live;
19 20	(2) Does not limit length of stay before stabilizing, improving health, reducing harmful behaviors or increasing income of the person;
21	(3) Prioritizes connecting the person to a permanent home as quickly as possible;
22 23	(4) Removes barriers to accessing housing, including requirements for sobriety or absence of criminal history of the person; and
24 25 26	(5) Values the person's choices, including where to live and whether to participate in support services and does not require the person to participate in support services to access or retain housing.
27 28 29 30 31 32	E. "Mainstream resources" means housing, health, social services, employment, education and youth programs for which individuals and families experiencing homelessness and individuals and families at risk of homelessness may be eligible, including the MaineCare program, the Temporary Assistance for Needy Families program, the federal State Children's Health Insurance Program and other federal programs that assist homeless, indigent or underserved populations.
33 34	F. "Program" means the Emergency Housing Matching Grant Program established in subsection 2.
35 36 37	G. "Rapid rehousing" means rapidly connecting individuals and families experiencing homelessness to permanent housing through a tailored package of assistance that may include the use of time-limited financial assistance and targeted supportive services.
38 39 40 41	<b>2. Program established.</b> The Emergency Housing Matching Grant Program is established within the Maine State Housing Authority. The program requires applicants to match grant requests under the program on a one-to-one basis with funds from a source other than state funding.

1 2 3	<b>3. Purpose.</b> The purpose of the program is to provide grants to emergency housing or shelter programs for the construction, renovation or acquisition of a new or existing building to house the emergency housing or shelter programs.
4	<b>4. Recipient criteria.</b> A recipient of a grant under the program must:
5 6 7	A. Be a nonprofit corporation in good standing in the State and qualify as a tax-exempt organization under 26 United States Code, Section 501(c)(3) or a municipal corporation;
8 9	<u>B. Be eligible for funding under the McKinney-Vento Homeless Assistance Act, 42</u> <u>United States Code, Section 11301 et seq. (2009);</u>
10 11	C. Be a provider of homeless services with at least one year of experience providing emergency housing, street outreach, homeless prevention or rapid rehousing activities;
12 13 14 15	D. Be a regular and active participant in a state-based continuum eligible for homelessness funding from the United States Department of Housing and Urban Development and be compliant with the continuum's governance charter and performance criteria;
16 17 18 19 20	E. Be a regular and active participant in a regional homeless service hub administered by the Maine State Housing Authority serving the region of the recipient by participating in hub meetings and providing relevant data to the hubs for the generation of a by-name list of persons experiencing homelessness in an area served by the recipient;
21 22 23	<u>F. Have board or advisory board representation of persons experiencing homelessness</u> or having experienced homelessness who are involved in policy making or planning of the recipient;

Participate in a coordinated entry process that links persons who are experiencing homelessness or who are at risk of homelessness with appropriate housing or services by acting as an access point to the coordinated entry process, administering common tools to assess the needs of the persons, placing eligible persons on a housing prioritization list, participating in case conferencing meetings and making housing referrals using the processes and procedures designated by the continuum in paragraph $\underline{D}$ ;
31 32 33	<u>H. Have the administrative and financial management capacity necessary to administer</u> and to account for the use of the grant from the program in accordance with the grant's funding requirements;

Operate in accordance with the homelessness strategy outlined in the most recent consolidated housing and community development plan submitted by the Maine State Housing Authority to the United States Department of Housing and Urban Development outlining the State's goals and strategies for using federal funds to meet housing and community development needs;
39 40 41	J. If applicable, meet the procedural and administrative objectives for a grant from the program subject to recapture on certain terms and for certain purposes determined by the Maine State Housing Authority;
42 43	K. If the recipient is a victim services provider, participate in and meet the performance and reporting requirements of a homeless management information system that is a

Not engage in any explicitly religious activities, including worship, religious

If religious activities are offered by the recipient, the recipient must offer the religious activities at a separate time and location from the activities and services housed in a building constructed, renovated or acquired through a grant from the program and participation in those religious activities must be voluntary for a person participating in activities or receiving services housed in a building constructed, renovated or

Operate an emergency housing or shelter program free from discrimination on the basis of age, race, color, sex, religion, national origin, physical or mental disability, ancestry, sexual orientation or gender identity in accordance with applicable federal and state fair housing laws;
17 18	N. Comply with the federal Rehabilitation Act of 1973, 29 United States Code, Section 701 et seq.; and
19	O. Comply with any other requirements of the Maine State Housing Authority.
20 21	<b>5. Emergency housing or shelter program requirements.</b> An emergency housing or shelter program of a recipient of a grant under the program must:
22 23	A. Provide access 365 days per year to assist clients to meet basic emergency shelter needs;

4	K. Have no lease requirements for clients;
5 6	L. If serving families with children, provide space for a family other than open dormitory style and not require involuntary family separation for admission;
7 8	<u>M. Provide separate accommodations for male and female clients consistent with the gender identity of the clients;</u>
9	N. Protect the privacy, confidentiality and personal information of clients;
10 11	O. Provide training, policies, procedures and regular maintenance to encourage, improve and maintain the health and safety of clients, volunteers and staff;
12 13	<u>P. Post fire, disaster and other emergency procedures in a conspicuous place and review</u> the procedures with each client;
14 15	Q. Maintain a daily and confidential census of clients including precise sleeping locations;
16 17	<u>R. Operate in compliance with all applicable federal, state and local codes, laws, rules and regulations; and</u>
18 19	S. Have written policies and procedures for standards that meet federal guidelines in the following areas:
20	(1) Nondiscrimination;
21	(2) Client grievance and appeal of services termination;
22	(3) Approval of financial transactions;
23	(4) Record retention;
24	(5) Procurement;
25	(6) Whistleblowers;
26	(7) Access to shelter and services;
27	(8) Client rights and responsibilities;
28	(9) Personnel and facility operations;
29	(10) Health and safety;
30	(11) Food preparation and distribution;
31	(12) Electronic data and security;
32	(13) Fair housing; and
33	(14) Drug-free workplace.
34	6. Request for proposals; amount of grant. The Maine State Housing Authority shall
35 36	award grants on an annual basis and issue a request for proposals to award grants under the program no later than January 1st of the year in which a grant will be issued. The program
30 37	shall award a grant of \$10,000 per emergency housing bed up to \$1,000,000 per recipient.

Fund.</b> The Emergency Housing Matching Grant Program Fund, referred to in this subsection as "the fund," is established within the Maine State Housing Authority to fund grants under the program. The fund may receive money from appropriations, allocations, donations and other public or private sources. The fund is interest-bearing, and interest earned by the fund is credited to the fund. Funds in the fund do not lapse but carry over to the next fiscal year.
