## COMMITTEE AMENDMENT " " to S P 762, L D 1887

1	SUMMARY
2	This amendment changes the definition of "transmission project" in the law governing
3	Public Utilities Commission approval of construction of transmission projects to mean new
4	or upgraded transmission substation infrastructure that is capable of operating at 69
5	kilovolts or more The amendment also requires that nonwires alternatives be prudently
6	procured, instead of competitively procured, when the commission determines that a
7	nonwires alternative is appropriate under that law. It directs the commission to develop
8	criteria for excluding certain projects from commission approval, including investigation
9	by the nonwires alternative coordinator and review by the commission
