An Act to Provide for Enforcement of Snowmobile and All-terrain Vehicle Laws

1	Be it enacted by the People of the State of Maine as follows:		
2 3	Sec. 1. 12 MRSA §13104, sub-§4, as corrected by RR 2021, c. 1, Pt. A, §9, is amended to read:		
4 5	4. Fee. Except as provided in subsection 5, the annual snowmobile registration fee is as follows:		
6 7	A. For residents, $\$55$ $\$65$. The registration for a snowmobile owned by a resident is valid for one year, commencing on July 1st of each year; and		
8	B. For nonresidents:		
9 10	(1) Seventy-four <u>Eighty-four</u> dollars for a 3-consecutive-day registration. A person may purchase more than one 3-day registration in any season;		
11	(2) One hundred and nineteen twenty-nine dollars for a seasonal registration; and		
12 13 14	(3) <u>Ninety-nine</u> <u>One hundred and nine</u> dollars for a 10-consecutive-day registration. A person may purchase more than one 10-day registration in any season.		
15 16	The registration for a snowmobile owned by a nonresident must specify the dates for which the registration is valid.		
17 18 19 20 21 22 23	Ten dollars from each resident registration fee and \$15 from each nonresident registration fee collected pursuant to this subsection must be transferred to a special fund administered by the Off-Road Vehicle Division of the Bureau of Parks and Lands within the Department of Agriculture, Conservation and Forestry. The funds must be used to assist any entity that has a snowmobile trail grooming contract with the Bureau of Parks and Lands in the purchase of trail-grooming equipment. The funds also may be used for the repair or overhaul of trail-grooming equipment.		
24 25 26	Seventeen dollars from each resident snowmobile registration fee must be transferred to the Snowmobile Trail Fund of the Department of Agriculture, Conservation and Forestry, Bureau of Parks and Lands.		
27 28 29 30	Sixteen dollars from each nonresident 3-day snowmobile registration fee, \$16 from each nonresident 10-day snowmobile registration fee and \$21 from each nonresident seasonal snowmobile registration fee must be transferred to the Snowmobile Trail Fund of the Department of Agriculture, Conservation and Forestry, Bureau of Parks and Lands.		
31 32 33 34	Five <u>Fifteen</u> dollars from each nonresident 3-day snowmobile registration fee and 10-day snowmobile registration fee, <u>\$10 from each nonresident seasonal snowmobile registration</u> <u>fee and \$10 from each resident snowmobile registration fee</u> must be transferred to the Snowmobile Enforcement Fund established under section 10258.

37	5. Fees. The ATV registration fee is:		
38 39	A. For a resident, $\frac{570 \underline{880}}{100}$ annually. The registration for an ATV owned by a resident is valid for one year, beginning on July 1st of each year; and		
40	B. For a nonresident:		

1 2	(1) One hundred <u>and ten</u> dollars for a registration valid for 7 consecutive days. A			
2	person may purchase more than one 7-day registration in any season; and			
3	(2) One hundred fifteen and twenty-five dollars for a registration valid for one

5 6	The registration for an ATV owned by a nonresident must specify the dates for which the registration is valid.			
7 8 9	Thirty-seven dollars of each fee collected pursuant to this subsection must be deposited in the ATV Recreational Management Fund established in section 1893, subsection 2 and must be used to maintain designated state-approved ATV trails.			
10 11 12	Ten dollars of each fee collected pursuant to <u>paragraph A and \$20 of each fee collected</u> <u>pursuant to</u> paragraph B must be deposited in the ATV Enforcement Fund established in section 10267.

23	SUMMARY			
24	This bill increases registration fees for snowmobiles and all-terrain vehicles by \$10 and			
25	dedicates the additional revenue to the Snowmobile Enforcement Fund and the ATV			
26	Enforcement Fund, respectively. It provides an allocation for the purchase of 16 law			
27	enforcement all-terrain vehicles for use by the Department of Inland Fisheries and Wildlife			

28 for enforcement activities.
