COMMITTEE AMENDMENT "A" to H P 1238, L D 1930, "Resolve, to Authorize the Exchange of Interest in Certain Lands Owned by the State in Piscataquis County"

Amend the resolve in the 3rd paragraph after the title in the 3rd line (page 1, line 8 in L D) by striking out the following "Title 5, section 6209 and"

Amend the resolve in the 3rd paragraph after the title in the last line (page 1, line 9 in L D) by striking out the following "sections 1814, 1837 and" and inserting the following 'section'

Amend the resolve in section 1 in the last line (page 1, line 16 in L D) by inserting after the following "County " the following 'The cost of a survey of the property boundaries and recording costs may not be paid by the bureau '

Amend the resolve by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively

SUMMARY

This amendment specifies the statutory references in the preamble that apply to the exchange of interest in land authorized in the resolve The amendment provides that the cost of a survey of the property boundaries and recording costs may not be paid by the Department of Agriculture, Conservation and Forestry, Bureau of Parks and Lands

Fiscal Detail and Notes

This bill allows the Department of Agriculture, Conservation and Forestry to exchange approximately 1/4 of an acre of Public Reserved land in Chesuncook Township for land of comparable market value to resolve a boundary line dispute with a private landowner. Any costs related to the transfer will be paid by the private landowner
