COMMITTEE AMENDMENT ^A to H P 1256, L D 1954, "An Act to Address the Recent Mill Closure in the Town of Jay by Providing Funds to Offset Property Tax Loss"

Amend the bill by inserting after the title and before the enacting clause the following
'Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies, and

Whereas, the Town of Jay is experiencing economic hardships and financial difficulties due to the recent closure of a mill in that municipality, and

Whereas, the town will suffer additional financial difficulties due to the loss not only of the taxable value of the closed mill but also the loss of \$600,000 in state-municipal revenue sharing in fiscal year 2022-23 due to complicated municipal funding efforts, and

Whereas, it is to the benefit of the Town of Jay, and of the State as a whole, to provide financial support to the town during this period of financial distress, and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety, now, therefore,'

Amend the bill by striking out all of section 1 and inserting the following

'Sec. 1. Appropriations and allocations. The following appropriations and allocations are made

State Controller - Office of the 0056**

Initiative Provides a one-time appropriation to the Office of the State Controller to provide payment to the Town of Jay to help offset a property tax revenue loss from a recent mill closure
