HOUSE AMENDMENT "A" to H.P. 1258, L.D. 1956, "An Act to Amend the Laws Governing Optometrists"

Amend the bill in section 7 in c. 149 in sub-c. 4 in §19401 in subsection 2 by striking out all of paragraph A (page 12, line 33 in L.D.).

Amend the bill in section 7 in c. 149 in sub-c. 4 in §19401 in subsection 2 by striking out all of paragraph C (page 12, lines 35 and 36 in L.D.).

Amend the bill in section 7 in c. 149 in sub-c. 4 in §19401 in subsection 2 in paragraph D in the last line (page 12, line 38 in L.D.) by inserting after the following: "agencies;" the following: 'and'

Amend the bill in section 7 in c. 149 in sub-c. 4 in §19401 in subsection 2 by striking out all of paragraph E (page 13, lines 1 to 3 in L.D.).

Amend the bill in section 7 in c. 149 in sub-c. 4 in §19401 in subsection 2 in paragraph F in the last line (page 13, line 7 in L.D.) by striking out the following: "; and" and inserting the following: ';

Amend the bill in section 7 in c. 149 in sub-c. 4 in §19401 in subsection 2 by striking out all of paragraph G (page 13, lines 8 to 12 in L.D.).

Amend the bill in section 7 in c. 149 in sub-c. 4 in §19401 in subsection 2 by relettering the paragraphs to read alphabetically.

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

SUMMARY

This amendment removes language in the bill related to the authority of the Commissioner of Professional and Financial Regulation with respect to investigation of
