A school administrative unit may contract with an appropriate entity to provide social work and family therapy services for students within the school administrative unit. Services provided as authorized by this section must be provided by an individual with one of the following licenses:			
10	A. Licensed master social worker;			
11	B. Licensed master social worker, clinical conditional;			
12	C. Licensed clinical social worker;			
13	D. Licensed clinical social worker, clinical conditional;			
14	E. Licensed marriage and family therapist; or			
15	F. Licensed marriage and family therapist, clinical conditional.			
16 17 18 19	Sec. 2. Grant program required. The Department of Education shall administer a grant program to provide money to school administrative units that contract for social work and family therapy services as authorized by the Maine Revised Statutes, Title 20-A, section 6701 according to the population of the school administrative unit as follows:			
20	1. Two hundred fifty or fewer students, \$3,000;			
21	2. Two hundred fifty-one to 500 students, \$6,000; and			
22	3. More than 500 students, \$9,000.			
23 24	Money received under the grant program may be used only to pay the cost of the contract to provide social work and family therapy services.

2	This bill authorizes a school administrative unit to contract for social work and family
3	therapy services for students within the school administrative unit and directs the
4	Department of Education to administer a grant program to provide money to those school
5	administrative units according to the school administrative unit's population.
