9 10	COMMITTEE AMENDMENT " A " to S.P. 828, L.D. 2006, "An Act to Amend the Laws Regarding Adjustments for Sudden and Severe Disruption of Municipal Valuation"
11	Amend the bill by inserting after the title and before the enacting clause the following:
12 13	'Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and
14 15 16	Whereas, municipalities will be evaluating their resources and preparing their budgets sooner than 90 days after adjournment of the Second Regular Session of the 131st Legislature; and
17 18 19	Whereas, enactment of this bill may result in the availability of additional revenue for some municipalities that qualify for a sudden and severe disruption of valuation adjustment; and
20 21	Whereas, it is necessary to maximize the ability of municipalities to consider the availability of additional revenue when preparing their budgets; and
22 23 24 25	Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,'
26	Amend the bill by inserting after section 2 the following:
27 28	'Sec. 3. Application. This Act applies to adjustments for revenue sharing years beginning on or after July 1, 2024 or the effective date of this Act, whichever is later.'
29	Amend the bill by adding before the summary the following:
30 31	'Emergency clause. In view of the emergency cited in the preamble, this legislation takes effect when approved.'
32 33	Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.
