Amend the bill in section 2 in subsection 7-A in the last line (page 1, line 17 in L.D.) by striking out the following: "January" and inserting the following: 'July'

Amend the bill in section 5 in §2804-M in subsection 1 in the first line (page 1, line 33 in L.D.) by striking out the following: "January" and inserting the following: 'July'

Amend the bill in section 6 in §2804-N in subsection 1 in the first line (page 2, line 3 in L.D.) by striking out the following: "January" and inserting the following: 'July'

Amend the bill in section 7 in subsection 1 in the last line (page 2, line 27 in L.D.) by striking out the following: "January" and inserting the following: 'July'

Amend the bill in section 7 in subsection 1 in the last line (page 2, line 27 in L.D.) by striking out the following: "April" and inserting the following: 'October'

Amend the bill in section 7 in subsection 2 in the first line (page 2, line 28 in L.D.) by striking out the following: "April" and inserting the following: 'October'

Amend the bill in section 8 in the last line (page 2, line 37 in L.D.) by striking out the following: "January" and inserting the following: 'July'

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

SUMMARY

This amendment moves the date by which the Board of Trustees of the Maine Criminal Justice Academy must establish training and certification standards for probation and parole officers, and the date by which new probation and parole officers must comply with those standards, from January 1, 2025 to July 1, 2025. It also moves the date the provisional
