health and human services matters on efforts to combat fraud, waste and abuse in the delivery of hospice services, shall include in the report information on federal initiatives that include Medicaid hospice providers and shall make recommendations regarding the application of electronic visit verification to hospice services under the MaineCare program.'

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

SUMMARY

9 This amendment replaces the bill and changes the title. It makes rules regarding 10 electronic visit verification for providers offering hospice services under the MaineCare 11 program major substantive rules, prohibits the Department of Health and Human Services from implementing electronic visit verification earlier than March 1, 2025 and directs the 12 13 department by February 1, 2025 to report to the joint standing committee of the Legislature 14 having jurisdiction over health and human services matters on efforts to combat fraud, 15 waste and abuse in the delivery of hospice services, to include in the report information on 16 federal initiatives that include Medicaid hospice providers and to make recommendations 17 regarding the application of electronic visit verification to hospice services under the 18 MaineCare program. The amendment also removes the emergency preamble and 19 emergency clause.
