An Act to Require the State Board of Examiners of Psychologists and the Board of Examiners in Physical Therapy to Obtain Fingerprint-based Federal Bureau of Investigation Criminal Background Checks for Applicants for Licensure

2	Sec. 1. 25 MRSA §1542-A, sub-§1, ¶AA is enacted to read:
3 4	AA. Who is an applicant for licensure as a psychologist with the State Board of Examiners of Psychologists as required under Title 32, section 3833-B.

6 7 8	BB. Who is an applicant for licensure as a physical therapist or a physical therapy assistant with the Board of Examiners in Physical Therapy as required under Title 32, section 3114-D.

Background check.</b> The board shall request a background check for each person who submits an application for initial licensure or licensure by endorsement as a physical therapist or a physical therapist assistant under this chapter. The background check must include criminal history record information obtained from the Maine Criminal Justice Information System, established in Title 16, section 631, and the Federal Bureau of Investigation.
27 28 29	A. The criminal history record information obtained from the Maine Criminal Justice Information System must include a record of public criminal history record information as defined in Title 16, section 703, subsection 8.
30 31	B. The criminal history record information obtained from the Federal Bureau of Investigation must include other state and national criminal history record information.
32 33 34 35	C. An applicant shall submit to having fingerprints taken. The Department of Public Safety, Bureau of State Police, upon payment by the applicant of a fee established by the board, shall take or cause to be taken the applicant's fingerprints and shall forward the fingerprints to the Department of Public Safety, Bureau of State Police, State
36 37	Bureau of Identification so that the State Bureau of Identification can conduct state and national criminal history record checks. Except for the portion of the payment, if any,

12 13 14 15	F. Information obtained pursuant to this subsection is confidential. The results of background checks received by the board are for official use only and may not be disseminated to the physical therapy compact commission, established under section 18708, or to any other person.

Rules adopted pursuant to this subsection are routine technical rules as defined in Title 5, chapter 375, subchapter 2-A. 29 30 **SUMMARY** 31 This bill requires the State Board of Examiners of Psychologists and the Board of 32 Examiners in Physical Therapy to obtain national and state fingerprint-based criminal 33 history record information for certain applicants for initial licensure and licensure by 34 endorsement by each board.
