That certificate is valid for the period designated by the <u>licensed</u> physician, <u>physician assistant</u> , <u>nurse practitioner or registered nurse</u> , which may not exceed 6 years. The Secretary of State may issue a removable windshield placard that is visible to law enforcement officers to a person with a certificate from a <u>licensed</u> physician, <u>physician assistant</u> , <u>nurse practitioner or registered nurse</u> . A removable windshield placard is a 2-sided permit designed to hang from the rearview mirror when the vehicle is in motion without obstructing the view of the operator. The placard must be displayed by hanging it from the rearview mirror so that it may be viewed from the front and rear of the vehicle when the vehicle is in motion. If the vehicle is not equipped with a rearview mirror, the placard must be displayed on the dashboard. The placard must be identifiable as a seat belt placard as designed by the Secretary of State. A placard issued to a person under this paragraph expires when the <u>licensed</u> physician's, <u>physician assistant's</u> , <u>nurse practitioner's or registered nurse's certificate expires.'</u> |

| 37 38 39 | 2. It clarifies the definition of "antique motorcycle" in the bill to mean a motorcycle that is more than 35 years old or is 35 years old or less and more than 25 years old and was registered in the State as an antique motorcycle prior to January 2025. |
