COMMITTEE AMENDMENT " A " to S.P. 881, L.D. 2088 (5-55)

The bureau may issue one additional agency liquor store license beyond those otherwise authorized by this subsection in a <u>any</u> municipality with a population of less than 10,000. The bureau may consider the impact of seasonal population or tourism and other related any information provided by the municipality requesting an additional agency liquor store license.

6 Sec. 4. Department of Administrative and Financial Services, Bureau of 7 Alcoholic Beverages and Lottery Operations to convene stakeholder group 8 regarding licensing and operation of agency liquor stores. The Department of Administrative and Financial Services, Bureau of Alcoholic Beverages and Lottery 9 Operations shall convene a stakeholder group to examine how agency liquor stores, as 10 defined in the Maine Revised Statutes, Title 28-A, section 2, subsection 1, are licensed and 11 operated in order to better understand how agency liquor stores are distributed throughout 12 the State and to evaluate the effectiveness of the current system for consumers, the general 13 public, local law enforcement officials, municipalities, the State and entities licensed in this 14 State for the sale of liquor. The stakeholder group must include, at a minimum, 15 representatives of agency liquor stores, on-premises retail licensees as defined in Title 16 28-A, section 2, subsection 27, paragraph B, off-premises retail licensees as defined in Title 17 28-A, section 2, subsection 27, paragraph A, certificate of approval holders under Title 18 19 28-A, sections 1361 and 1381 and in-state manufacturers licensed under Title 28-A, section 1355-A; wholesale licensees as defined in Title 28-A, section 2, subsection 34; municipal 20 representatives; and local law enforcement officials. No later than November 6, 2024, the 21 bureau shall submit a report summarizing any conclusions reached and proposals supported 22 by the stakeholder group, which may include suggested legislation, to the joint standing 23 24 committee of the Legislature having jurisdiction over alcoholic beverages matters. The committee may submit legislation related to the report to the 132nd Legislature in 2025.'

Amend the bill by adding before the summary the following:

'Emergency clause. In view of the emergency cited in the preamble, this legislation takes effect when approved.'

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

SUMMARY

32 This amendment authorizes the Department of Administrative and Financial Services, Bureau of Alcoholic Beverages and Lottery Operations to issue one additional agency 33 liquor store license to any municipality instead of to only a municipality with a population 34 of less than 15,000 as in the bill. In determining whether to issue an additional license, the 35 bureau may consider any information provided by the municipality requesting an additional 36 agency liquor store license. The amendment directs the bureau to convene a stakeholder 37 group to examine how agency liquor stores are licensed and operated in order to better 38 39 understand how they are distributed throughout the State and to evaluate the effectiveness 40 of the current system for consumers, the general public, local law enforcement officials, municipalities, the State and entities licensed in this State for the sale of liquor. 41

Fiscal Detail and Notes

This bill allows the Bureau of Alcoholic Beverages and Lottery Operations (BABLO) to issue one additional ager liquor store license to any municipality. Any additional revenue from these licenses is not expected to be significan. Any additional costs to BABLO as a result of convening a stakeholder group to evaluate the effectiveness of the current liquor licensing system are anticipated to be minor and can be absorbed within existing budgeted resources.
