18 19	Sec. 2. Commission membership. Resolved: That, notwithstanding Joint Rule 353, the commission consists of 15 members, including:

Two members of the Senate, appointed by the President of the Senate, who serve on the Joint Standing Committee on Education and Cultural Affairs, including one member of the party holding the largest number of seats in the Legislature and one member of the party holding the 2nd largest number of seats in the Legislature;
24 25 26 27	2. Three members of the House of Representatives, appointed by the Speaker of the House, who serve on the Joint Standing Committee on Education and Cultural Affairs, including 2 members of the party holding the largest number of seats in the Legislature and one member of the party holding the 2nd largest number of seats in the Legislature;
28 29	3. One member with expertise in higher education policy issues representing a statewide education policy research institute, appointed by the President of the Senate;
30 31	4. One member who is a representative of a union representing the faculty of the Maine Community College System, appointed by the President of the Senate;
32 33	5. One member representing the certification and higher education committee of the State Board of Education, appointed by the President of the Senate;

- 6. One member who is a representative of a union representing the faculty of the University of Maine System, appointed by the Speaker of the House;
- 7. One member who is a representative of a union representing the faculty of the Maine Maritime Academy, appointed by the Speaker of the House;
- 8. One member who is currently enrolled as a student at a college or university in the State, appointed by the Speaker of the House;
 - 9. The Chancellor of the University of Maine System or the chancellor's designee;
- 10. The President of the Maine Community College System or the president's designee;
 - 11. The President of the Maine Maritime Academy or the president's designee; and
 - 12. The Commissioner of Education or the commissioner's designee.

In appointing members of the commission, the appointing authorities shall give consideration to race, gender, socioeconomic diversity and geographic diversity.

- Sec. 3. Chairs. Resolved: That the first-named Senate member is the Senate chair and the first-named House of Representatives member is the House chair of the commission.
- Sec. 4. Appointments; convening of commission. Resolved: That all appointments must be made no later than 30 days following the effective date of this resolve. The appointing authorities shall notify the Executive Director of the Legislative Council once all appointments have been completed. After appointment of all members, the chairs shall call and convene the first meeting of the commission. If 30 days or more after the effective date of this resolve a majority of but not all appointments have been made, the chairs may request authority and the Legislative Council may grant authority for the commission to meet and conduct its business.
- Sec. 5. Duties. Resolved: That the commission shall review the methods and mechanisms by which public institutions of higher education in the State are funded and make recommendations for potential changes.

In conducting its review, the commission shall analyze present and past funding methods and mechanisms used in the State to determine the State's portion of funding for the University of Maine System, the Maine Community College System and the Maine Maritime Academy. The commission shall also explore funding mechanisms used by other states to fund public institutions of higher education.

To assist the commission in carrying out its review, the Department of Education, the University of Maine System, the Maine Community College System and the Maine Maritime Academy each shall provide to the commission any data and information the commission requests and considers relevant to its work.

At the discretion of the chairs, the commission may seek input from students, faculty and staff in the State's public institutions of higher education, groups that have an interest in the State's public institutions of higher education and other stakeholders.

Sec. 6. Staff assistance. Resolved: That the Legislative Council shall provide necessary staffing services to the commission, except that Legislative Council staff support is not authorized when the Legislature is in regular or special session.

The general operating expenses of this study are projected to be \$3,750 in fiscal year 2024-25. The Legislature's budget for the 2024-2025 biennium includes \$14,500 in each of fiscal years 2023-24 and 2024-25 for the costs of legislative studies, as well as \$38,909 of balances carried over from prior years for this purpose. Whether these amounts are sufficient to fund all studies will depend on the number of studies authorized by the Legislative Council and the Legislature. The additional costs of providing staffing assistance to the study during the interim can be absorbed utilizing existing budgeted staff resources.

Fiscal Detail and Notes

Additional costs to the State Board of Education, the University of Maine System, the Maine Community College System, Maine Maritime Academy and the Department of Education associated with serving on the commission can be absorbed within existing budgeted resources.
