3 Sec. 7. Referendum; effective dates. This Act takes effect when approved only 4 for the purpose of permitting its submission to the legal voters within the Town of Wiscasset, the Town of Edgecomb and the Town of Woolwich at elections called for that 5 purpose and held within 3 years of the effective date of this Act. The elections must be 6 7 called, advertised and conducted according to the law relating to municipal elections. The registrars of the Town of Wiscasset, the Town of Edgecomb and the Town of Woolwich 8 9 shall make a complete list of all eligible voters of the proposed district as described in sections 1 to 5. The list prepared by the registrars governs the eligibility of a voter to vote 10 in an election pursuant to this Act. For the purpose of registration of voters, the registrars 11 12 of voters must be in session the secular day preceding the election. An election must be called by the municipal officers of each of the 3 towns named in this section and must be 13 held at the regular voting places. The residents of the Town of Wiscasset must be asked 14 15 all 4 questions. The residents of the Town of Edgecomb must be asked only the first 2 questions. The residents of the Town of Woolwich must be asked only the 4th question. 16 17 The subject matter of this Act is reduced to the following questions:

- 3. "Do you favor expanding the authority of the Wiscasset Water District
 to allow the district to provide sewer service to the Town of Wiscasset?"
- 4. "Do you favor expanding the authority of the Wiscasset Water District
 to allow the district to provide sewer service to the district's existing
 customers in the Town of Woolwich?"
- The voters shall indicate by a cross or check mark placed against the word "Yes" or "No" their opinion of the same.

The results must be declared by the municipal officers of the Town of Wiscasset, the
Town of Edgecomb and the Town of Woolwich and due certificate of the results filed by
the towns' clerks with the Secretary of State.

If the first question fails, section 2 does not take effect. If the 2nd question fails, section
3 does not take effect. If the 3rd question fails, section 4 does not take effect. If the 4th
question fails, section 5 does not take effect. If both the first and 2nd questions fail, section
6 does not take effect.

This Act takes effect for all other purposes immediately upon its approval by a majority of the legal voters voting at the elections. Failure to achieve the necessary approval in any referendum does not prohibit subsequent referenda consistent with this section, as long as the referenda are held within 3 years of the effective date of this Act.

- This bill amends the charter of the Wiscasset Water District to expand the district's
 service territory to include the Town of Edgecomb and to allow the district to provide sewer

- service to the Town of Edgecomb and the Town of Wiscasset and to existing customers in the Town of Woolwich. It also provides for representation of Edgecomb on the district's 2 board of trustees once service is expanded to include 1/3 of the legal residents of 3
- 4 Edgecomb.
