COMMITTEE AMENDMENT "A" to H.P. 1348, L.D. 2124, "An Act to Clarify the Eligibility of an Off-track Betting Facility to Receive Funding If the Facility Is Sold or Relocates"

Amend the bill by striking out the title and substituting the following:

'An Act to Clarify the Eligibility of an Off-track Betting Facility to Receive Funding'

Amend the bill in section 1 in subsection 1 in the 2nd, 3rd and 4th lines (page 1, lines 5 to 7 in L.D.) by striking out the following: "as of December 31, 2003, regardless of whether the facility relocates or is sold after December 31, 2003" and inserting the following: 'as of December 31, 2003 in the State'

Amend the bill in section 2 in subsection 2 in the 4th and 5th lines (page 1, lines 15 and 16 in L.D.) by striking out the following: "December 31, 2003, regardless of whether the facility relocates or is sold after December 31, 2003" and inserting the following: 'December 31, 2003 the date of the distribution'

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

SUMMARY

This amendment provides that the Fund to Stabilize Off-track Betting Facilities provides revenues to off-track betting facilities licensed and in operation in the State on the date of the distribution from the fund.
