11	Amend the resolve by inserting before section 1 the following:
12 13	'Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and
14 15	Whereas, Bridge 2540 on Elm Street in the Town of Mechanic Falls is slated for renovation in 2025; and
16	Whereas, this legislation provides for the renaming of Bridge 2540; and
17 18 19	Whereas, it is imperative that this legislation take effect as soon as possible in order to timely expedite the renaming process prior to the beginning of the renovation process; and
20 21 22 23	Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it'
24	Amend the resolve by adding before the summary the following:
25 26	'Emergency clause. In view of the emergency cited in the preamble, this legislation takes effect when approved.'
27 28	Amend the resolve by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.
29	SUMMARY
30	This amendment adds an emergency preamble and an emergency clause.
