An Act to Require Public Safety Answering Point and Dispatch Center Cost Reporting and to Direct the Formation of a Staffing and Recruiting Stakeholder Group

Reported by Senator LAWRENCE of York for the Joint Standing Committee on Energy, Utilities and Technology pursuant to Public Law 2023, chapter 186, section 3.

1 Be it enacted by the People of the State of Maine as follows: 2 **Sec. 1. 25 MRSA §2921, sub-§4-A** is enacted to read: 3 4-A. Dispatch center. "Dispatch center" means an emergency communications center that receives 9-1-1 calls from a public safety answering point rather than receiving the calls 4 5 directly. 6 Sec. 2. 25 MRSA §2921, sub-§4-B is enacted to read: 4-B. Emergency communications center. "Emergency communications center" has 7 the same meaning as in Title 17-A, section 509, subsection 1. 8 9 Sec. 3. 25 MRSA §2923-C is enacted to read: 10 §2923-C. Cost reporting 1. Reporting requirements. Annually, on a date prescribed by the bureau by rule, a 11 12 public safety answering point and dispatch center shall each provide the bureau with a report of the costs incurred by the public safety answering point or dispatch center for the 13 provision of enhanced 9-1-1 services. 14 15 2. Rules. The bureau shall adopt rules to implement this section. The rules must establish requirements for the report provided by a public safety answering point and 16 17 dispatch center pursuant to subsection 1, including, at a minimum: 18 A. The manner by which the report must be submitted to the bureau; 19 B. The specific cost components for the provision of enhanced 9-1-1 services to be 20 included in the report; and 21 C. The date by which the report must be submitted. 22 Rules adopted pursuant to this subsection are routine technical rules pursuant to Title 5, 23 chapter 375, subchapter 2-A. 24 Sec. 4. 25 MRSA §2927, sub-§3-E is enacted to read: 25 **3-E.** Quality assurance review support. The bureau shall contract with one or more 3rd-party vendors, using revenues in the E-9-1-1 fund, to provide quality assurance review 26 in accordance with rules adopted pursuant to subsection 3-C, paragraph A and Title 32, 27 section 85-A, related to the provision of emergency medical dispatch services and 28 29 answering fire 9-1-1 calls by public safety answering points. 30 Sec. 5. Public safety answering point staffing crisis stakeholder group. The Public Utilities Commission, Emergency Services Communication Bureau shall convene a 31 stakeholder group to develop a coordinated 9-1-1 staffing and recruiting effort for all public 32 33 safety answering points. The bureau shall ensure that there is stakeholder representation 34 from state, county and municipal public safety answering points. On or before February 35 21, 2025, the bureau shall submit to the joint standing committee of the Legislature having jurisdiction over utilities and energy matters a report that includes any recommendations, 36 37 including suggested legislation as necessary. The committee may report out a bill related to the report to the 132nd Legislature in 2025. 38

This bill is reported out by the Joint Standing Committee on Energy, Utilities and Technology pursuant to Public Law 2023, chapter 186, section 3. It does the following.

- 1. It requires each public safety answering point and dispatch center to annually provide a report to the Public Utilities Commission, Emergency Services Communication Bureau on the costs they incur for the provision of enhanced 9-1-1 services.
- 2. It requires the bureau to contract with one or more 3rd-party vendors, using revenues in the E-9-1-1 fund, to provide quality assurance review related to the provision of emergency medical dispatch services and answering fire 9-1-1 calls by public safety answering points.
- 3. It requires the bureau to convene a stakeholder group to develop a coordinated 9-1-1 staffing and recruiting effort for all public safety answering points. The bureau must ensure that there is representation on the stakeholder group from state, county and municipal public safety answering points. The bureau must submit a report to the joint standing committee of the Legislature having jurisdiction over utilities and energy matters including any recommendations.

Fiscal Detail and Notes

This bill includes ongoing allocations of \$105,227 to the Public Utilities Commission (PUC) starting in fiscal year 2024-25 for one Staff Development Specialist IV position and associated costs. The bill also includes ongoing allocations of \$100,000 to the PUC beginning in fiscal year 2024-25 for contracted services to provide quality assurance reviews. Additional costs to the Department of Public Safety to participate in a stakeholder group are expected to be minor and can be absorbed within existing budgeted resources.
