SENATE AMENDMENT "A" to COMMITTEE AMENDMENT "A" to H.P. 560,  
L.D. 874, "An Act to Provide Relief to Federal or State Employees Affected by a Federal  
Government or State Government Shutdown"

Amend the amendment by inserting after the first instructional paragraph the  
following:

'Amend the bill in section 3 in the 2nd line (page 5, line 32 in L.D.) by striking out the  
following: "General Fund unappropriated surplus" and inserting the following: 'Financial  
Institutions - Bureau of program, Other Special Revenue Funds account within the  
Department of Professional and Financial Regulation'

Amend the bill by striking out all of section 5 and inserting the following:

**'Sec. 5. Appropriations and allocations.** The following appropriations and  
allocations are made.

**Fiscal Detail and Notes**
