SENATE AMENDMENT "A" to COMMITTEE AMENDMENT "A" to H.P. 840,
L.D. 1265, "An Act to Amend the Laws Governing Public Employee Market Pay Studies
and Comprehensive Reviews of the Classification Plan for State Service Positions"

Amend the amendment by inserting after the first instructional paragraph the
following:

'Sec. 3. Funds transfer. Notwithstanding any provision of law to the contrary, the
State Controller shall transfer \$2,000,000 on or before June 30, 2027 from the Department
of Administrative and Financial Services, Salary Plan program, General Fund account to
the unappropriated surplus of the General Fund to provide funding to contract with
contractors to complete market pay studies and reviews pursuant to the Maine Revised
Statutes, Title 5, section 7061, subsection 4, paragraphs B and C.'

Amend the amendment by relettering or renumbering any nonconsecutive Part letter or
section number to read consecutively.

This amendment allows the State Controller to transfer \$2,000,000 on or before June 30, 2027 from the Salary Plan program, General Fund account within the Department of Administrative Services to the unappropriated surplus of the General Fund to provide funding to issue a request for proposals and contract with an experienced consultant to complete market pay studies and reviews prior to the report deadline of September 30, 2028.
