Fiscal Detail and Notes

This amendment allows the State Controller to transfer \$2,000,000 on or before June 30, 2027 from the Salary Plan program, General Fund account within the Department of Administrative Services to the unappropriated surplus of the General Fund to provide funding to issue a request for proposals and contract with an experienced consultant to complete market pay studies and reviews prior to the report deadline of September 30, 2028.
