Amend the amendment by striking out all of section 4 and inserting the following:

Sec. 4. Appropriations and allocations. The following appropriations and allocations are made.

Initiative: Provides base allocations to authorize expenditures for funds received from outside sources to support the Maine-Aomori Sister-state Advisory Council.

Fiscal Detail and Notes

This amendment eliminates the ongoing General Fund appropriations included in the bill of \$20,000 per year beginning in fiscal year 2025-26 to support the work of the Maine-Aomori Sister-state Advisory Council and instead provides ongoing Other Special Revenue Funds base allocations of \$500 per year beginning in fiscal year 2025-26 to authorize the expenditure of funds in the event money is received from outside sources to support the council.
