No later than November 4, 2026, the Governor's Energy Office shall submit a report, including findings, recommendations and any suggested legislation, based on the study to the joint standing committee of the Legislature having jurisdiction over taxation matters. The joint standing committee may report out legislation related to the report to the 133rd Legislature in 2027.''

24 25 26 27 28	'Sec. 2. Funding. Resolved: That the Governor's Energy Office may receive funds, grants or contributions from public or private sources to carry out the study required under section 1. The Governor's Energy Office shall disclose its sources of funding as part of the report required in section 1. The Governor's Energy Office is not required under this resolve to undertake work for which it does not have or has not received sufficient funding.'

Fiscal Detail and Notes

This amendment removes the General Fund appropriations of \$75,000 to the Governor's Energy Office (GEO) in fiscal year 2025-26. The amendment changes the due date of required reporting from December 5, 2025, to December 5, 2026. It adds language that allows the GEO to accept private and public sources to fund the costs associated with the required reporting.
