COMMITTEE AMENDMENT "B" to H.P. 911, L.D. 1389, "An Act to Create the Building Opportunity Through Out-of-school Time Program"

Amend the bill in section 1 in c. 1083 in §4100-B in subsection 2 in paragraph F in the last line (page 2, line 34 in L.D.) by striking out the following: "section 1053-B" and inserting the following: 'chapter 1053-B'

Amend the bill in section 1 in c. 1083 in §4100-B by inserting after subsection 3 the following:

'4. Implementation. The department may not take steps to implement the program until the Legislature provides funding sufficient for the department to issue the grant awards outlined in section 4100-C.'

Amend the bill in section 1 in c. 1083 in §4100-C in subsection 1 in the first line (page 3, line 3 in L.D.) by striking out the following: "By December 1, 2026, the" and inserting the following: 'The'

Amend the bill in section 1 in c. 1083 in §4100-D in subsection 1 in the first line (page 4, line 4 in L.D.) by striking out the following: "No later than February 1, 2027 and each" and inserting the following: 'Each'

Amend the bill in section 1 in c. 1083 in §4100-D in subsection 1 in the first line (page 4, line 4 in L.D.) by striking out the following: "thereafter" and inserting the following: 'after a fiscal year'

Amend the bill in section 1 in c. 1083 in §4100-D in subsection 2 in the 3rd line (page 4, line 36 in L.D.) by striking out the following: "annual"

Amend the bill by striking out all of section 2 and inserting the following:

'Sec. 2. Appropriations and allocations. The following appropriations and allocations are made.

The bill includes an ongoing Other Special Revenue Funds base allocation to the Department of Health and Human Services of \$500 beginning in fiscal year 2025-26 to establish the Building Opportunity Through Out-of-school Time Program Fund and allow for the expenditure of funds to expand out-of-school programming in the event that public or private funds are received.
