Emergency preamble. Whereas, acts and resolves of the Legislature do not 1 2 become effective until 90 days after adjournment unless enacted as emergencies; and 3 Whereas, state tax law needs to be updated to conform to federal law before the 90day period expires to avoid delay in the processing of income tax returns for 2025; and 4 5 Whereas, legislative action is immediately necessary to ensure continued and efficient administration of the state income tax and certain other state taxes; and 6 Whereas, in the judgment of the Legislature, these facts create an emergency within 8 the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, 9 10 therefore, 11 Be it enacted by the People of the State of Maine as follows: 12 Sec. 1. 36 MRSA §111, sub-§1-A, as amended by PL 2025, c. 432, §1 and affected by §2, is further amended to read: 13 14 1-A. Code. "Code" means the United States Internal Revenue Code of 1986 and amendments to that Code as of December 31, 2024 2025. 15 **Sec. 2.** Application. This Act applies to tax years beginning on or after January 1, 16 2025 and to any prior tax year as specifically provided by the United States Internal 17 Revenue Code of 1986 and amendments to that Code as of December 31, 2025. 18 19 **Emergency clause.** In view of the emergency cited in the preamble, this legislation 20 takes effect when approved. SUMMARY 21 22 This bill updates references to the United States Internal Revenue Code of 1986 23 contained in the Maine Revised Statutes, Title 36 to refer to the United States Internal Revenue Code of 1986 as amended through December 31, 2025, for tax years beginning 24 25 on or after January 1, 2025 and for any prior tax year as specifically provided by the United 26 States Internal Revenue Code of 1986, as amended.
