An Act to Update the Requirements for Social Worker Licensure

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 32 MRSA §7001-A, sub-§7-A** is enacted to read:

3 **7-A. Licensed master social worker - conditional clinical.** "Licensed master social
4 worker - conditional clinical" means a person who has met the educational requirements as
5 a licensed clinical social worker and is working to meet the consultation and the social
6 work experience requirements of this chapter.

7 **Sec. 2. 32 MRSA §7001-A, sub-§8-A** is enacted to read:

8 **8-A. Licensed social worker - conditional.** "Licensed social worker - conditional"
9 means a person who has met the educational requirements as a licensed social worker and
10 is working to meet the consultation and the social work experience requirements of this
11 chapter.

12 **Sec. 3. 32 MRSA §7051**, as amended by PL 1985, c. 736, §9, is further amended to
13 read:

14 **§7051. License required**

15 In order to safeguard the life, health and welfare of the people of this State, any person
16 practicing or offering to practice ~~as a certified social worker— independent practice or~~
17 ~~licensed clinical, licensed master or licensed social worker shall be~~ social work under this
18 chapter is required to submit evidence to the board that he the person is qualified to so
19 practice and shall must be licensed as provided in this subchapter.

20 ~~The board may grant a conditional license to any person eligible to take the~~
21 ~~examination for licensure while waiting to sit for the examination or to any person who is~~
22 ~~waiting to retake the examination according to rules issued by the board.~~

23 **Sec. 4. 32 MRSA §7053, first ¶**, as amended by PL 2007, c. 402, Pt. V, §7, is
24 further amended to read:

25 To be eligible for a license to practice social work at any level, an applicant must be at
26 least 18 years of age ~~and must satisfactorily pass any examination as the board may~~
27 ~~prescribe by its rules. Each applicant, must demonstrate trustworthiness and competence to~~
28 engage in the practice of social work in such a manner as to safeguard the interests of the
29 public and must have demonstrated to the satisfaction of the board adherence to the ethics
30 of the social work profession. Applications for licensure must be submitted to the board
31 together with the fee as set under section 7056.

32 **Sec. 5. 32 MRSA §7053, sub-§1**, as amended by PL 2013, c. 262, §3, is further
33 amended by repealing the 3rd blocked paragraph.

34 **Sec. 6. 32 MRSA §7053, sub-§1**, as amended by PL 2013, c. 262, §3, is further
35 amended by enacting at the end a new last blocked paragraph to read:

36 For purposes of meeting the requirements of this subsection, an applicant is not required to
37 be licensed as a licensed master social worker - conditional clinical under this chapter in
38 order to qualify as a licensed clinical social worker. The board shall consider consultation
39 and social work experience previously obtained in this State or another jurisdiction as long
40 as that experience is substantially equivalent to the requirements of this chapter.

1 **Sec. 7. 32 MRSA §7053, sub-§2-A**, as enacted by PL 2003, c. 211, §2, is amended
2 to read:

3 **2-A. Licensed master social worker.** As To be qualified as a licensed master social
4 worker, an applicant must have received either a masters master's or doctoral degree in
5 social work or social welfare from an accredited educational institution, must have
6 demonstrated to the satisfaction of the board adherence to the ethics of the social work
7 profession and must have successfully completed the examination prescribed by the board.
8 After meeting these qualifications, the applicant must receive a "licensed master social
9 worker" license. In addition, any person wishing to practice social work in a clinical setting
10 must receive a "licensed master social worker, conditional" license.

11 This subsection takes effect July 1, 2005.

12 **Sec. 8. 32 MRSA §7053, sub-§2-B** is enacted to read:

13 **2-B. Licensed master social worker - conditional clinical.** To be qualified as a
14 licensed master social worker - conditional clinical, an applicant must have received either
15 a master's or doctoral degree in social work or social welfare from an accredited educational
16 institution, must have successfully completed the examination prescribed by the board and
17 must attest to obtaining the consultation and the social work experience requirements of
18 this chapter. The consultation arrangement must be with a licensed clinical social worker,
19 certified social worker - independent practice, licensed clinical professional counselor,
20 licensed marriage and family therapist, licensed psychologist, licensed psychiatrist or other
21 qualified consultant as determined by the board.

22 **Sec. 9. 32 MRSA §7053, sub-§3**, as amended by PL 2009, c. 112, Pt. A, §13, is

24 **3. Requirements to be a licensed Licensed social worker.** To be qualified to be
25 licensed as a licensed social worker, an applicant must attest to obtaining the consultation
26 and social work experience requirements of this chapter and meet one of the following
27 requirements:

28 A. The applicant must have received a bachelor's degree or higher in social work or
29 social welfare from an accredited educational institution; demonstrated to the
30 satisfaction of the board adherence to the ethics of the social worker profession; and
31 successfully completed the examination prescribed by the board; or

32 B. The applicant must have received a conditional license as a licensed social worker
33 in accordance with subsection 3-B; completed the requirements for consultation and
34 social work experience while licensed as a licensed social worker - conditional under
35 this chapter, must have completed contact hours in accordance with subsection 3-C,
36 paragraph B and subsection 3-D; and must have successfully completed the
37 examination prescribed by the board. For purposes of meeting the requirements of this
38 subsection, an applicant is not required to be actively licensed as a licensed social
39 worker - conditional under this chapter in order to qualify as a licensed social worker.

41 further amended to read:

1 **3-B. Conditional license as a licensed Licensed social worker - conditional.** The
2 board may issue a conditional license To be qualified as a licensed social worker to an
3 applicant who provides to the board - conditional, an applicant must provide:

4 A. Documented proof of a bachelor's degree or higher in a field that is sufficiently
5 related to social work or social welfare, ~~as determined by the board;~~ and attestation to
6 obtaining the consultation and social work experience requirements of this chapter. For
7 purposes of this paragraph, "field that is sufficiently related to social work or social
8 welfare" includes, but is not limited to, behavioral science, social and behavioral
9 sciences, childhood development, counseling, criminal justice, education, human
10 development, mental health and human services, nursing, psychology, educational
11 psychology, rehabilitation services, sociology and other sufficiently related fields as
12 determined by the board.

18 A licensed social worker - conditional license may be held for no more than 6 years.

21 **3-C. Consultation requirements for licensed social workers and conditionally**
22 **licensed social workers - conditional.** A licensed social worker or ~~conditionally~~ licensed
23 social worker - conditional must complete the following requirements for consultation.

24 A. A licensed social worker and a licensed social worker - conditional must complete
25 a minimum of 96 hours of consultation ~~as determined by the board.~~ This consultation
26 must be concurrent with the first 3,200 hours of social work employment occurring in
27 a period of not less than 2 years but not more than 4 6 years from initial licensure. The
28 consultation arrangement must be with a consultant who is a licensed social worker
29 licensed under this chapter who has at least 2 years of work experience as a licensed

15 further amended to read:

16 **4. Licensed social worker; licensed social worker - conditional.** A licensed social
17 worker or a licensed social worker - conditional may:

18 A. Engage in psychosocial evaluation, excluding the diagnosis and treatment of mental
19 illness, and conduct basic data gathering of records and specific life issues of
20 individuals, groups and families, assess this data and formulate and implement a plan
21 to achieve specific goals related to specific life issues;

22 B. Serve as an advocate for clients or groups of clients for the purpose of achieving
23 specific goals relating to specific life issues;

24 C. Refer clients to other professional services;

25 D. Plan, manage, direct or coordinate social services; and

26 E. Participate in training and education of social work students from an accredited
27 institution or an educational institution in candidacy for accreditation with the Council
28 on Social Work Education or a successor or other organization approved by the board
29 and supervise other licensed social workers.

30 A licensed social worker or a licensed social worker - conditional may not engage in the
31 private practice of social work, diagnose mental illness and emotional disorders or provide
32 psychotherapy. ~~A licensed social worker with less than 2 years' experience must receive~~
33 ~~consultation from either a licensed master social worker, a licensed clinical social worker~~
34 ~~or a certified social worker - independent practice in a manner to be prescribed by the board~~
35 ~~on a group or individual basis 4 hours a month. Licensed social workers in health care~~
36 ~~facilities licensed by the Department of Health and Human Services must receive~~
37 ~~consultation on a quarterly basis in a manner prescribed by the department. The department~~
38 ~~staff giving consultation to intermediate care facilities must be on the master or clinical~~

40 State agencies employing social workers are responsible for providing supervision
41 necessary for those social workers to maintain their licenses.

42 **Sec. 13. 32 MRSA §7060**, as amended by PL 2013, c. 262, §4, is further amended
43 to read:

1 **§7060. Expiration and renewals**

2 A license renewal fee as set under section 7056 must be paid by the licensee. Licenses
3 expire biennially on December 31st or at such other times as the Commissioner of
4 Professional and Financial Regulation may designate. Each renewal is contingent upon
5 evidence of participation in a continuing professional education course or program as
6 approved by the board. A license may be renewed up to 90 days after the date of expiration
7 upon payment of a late fee in addition to the renewal fee as set under section 7056. Any
8 person who submits an application for renewal more than 90 days after the renewal date is
9 subject to all requirements governing new applicants under this chapter, except that the
10 board may in its discretion, giving due consideration to the protection of the public, waive
11 examination if the renewal application is received, together with the late fee and renewal
12 fee, within 2 years from the date of the expiration.

13 Beginning January 1, 2020, an applicant for license renewal shall demonstrate to the
14 satisfaction of the board a one-time successful completion of a minimum of 12 hours of
15 course work in family or intimate partner violence, including course work in spousal or
16 partner abuse that addresses screening, referral and intervention strategies, including
17 knowledge of community resources, cultural factors, evidence-based risk assessment and
18 same-gender abuse dynamics. An applicant may fulfill this requirement through course
19 work provided through contact hours, Internet hours or distance learning programs, as
20 evidenced by certification from an accredited educational institution or equivalent teaching
21 or practice experience. The board may accept equivalent courses in family or intimate
22 partner violence screening and referral and intervention strategies or equivalent teaching
23 or practice experience completed prior to January 1, 2020 in satisfaction of this
24 requirement. Continuing education courses taken pursuant to this paragraph may be used
25 to satisfy the licensee's required hours of continuing education.

26 A licensee who is no longer actively practicing social work may apply for an inactive
27 status license pursuant to Title 10, section 8003, subsection 5-A, paragraph D,
28 subparagraph (5). The holder of an inactive status license may not practice social work in
29 the State. The fee for inactive status licensure is set under section 7056. The holder of an
30 inactive status license is required to renew the license annually and pay the renewal fee as
31 set under section 7056, but is not required to meet the continuing education requirement of
32 this chapter and the rules adopted under it.

33 ~~In addition to the other requirements of this section, a licensed social worker must:~~

34 ~~**1. Not employee of Department of Health and Human Services.** If not employed~~

This consultation must be concurrent with the first 3,200 hours of social work employment occurring in a period of not less than 2 years but not more than 4 years; or~~

~~B. A minimum of 96 hours of consultation concurrent with the person's first 3,200 hours of social work employment occurring in a period of not less than 2 years but not more than 4 years with a licensed social worker who has been licensed for at least 2 years, has been designated by the department as a supervisor trainee and is concurrently receiving 48 hours of consultation with a licensed master social worker.~~

A person who submits an application for license renewal more than 2 years from the date of expiration of the license is subject to all requirements governing new applicants under this chapter, except that the board may in its discretion, giving due consideration to the protection of the public, waive examination, consider consultation and work experience obtained under this chapter and require evidence of completing continuing professional education.

SUMMARY

This bill changes the licensure requirements for social workers. The bill enacts definitions of conditional licensure categories, identifies qualifying degrees for licensure, streamlines the qualifications for licensure specific to consultation and social work experience requirements, removes requirements for initial licensure that have created barriers to entering or re-entering the social work profession, clarifies the consultant eligibility, removes the 2-tiered system for eligibility for Department of Health and Human Services social workers and social workers who are not employees of the department and expands the State Board of Social Worker Licensure's authority to consider consultation and social work experience gained in this State or another jurisdiction when seeking initial licensure, late renewal or reinstatement of licensure.
