Amend the bill in section 1 in c. 203 in §1821 in subsection 1 in paragraph D in subparagraph (2) in the 3rd line (page 1, line 23 in L.D.) by inserting after the following: "the" the following: 'canine's last'

Amend the bill in section 1 in c. 203 in §1821 in subsection 2 in paragraph B in the 4th line (page 2, line 4 in L.D.) by striking out the following: "appropriated" and inserting the following: 'legislatively authorized'

Amend the bill in section 1 in c. 203 in §1821 in subsection 4 in paragraph C in the first line (page 2, line 21 in L.D.) by inserting after the following: "collected" the following: 'by state law enforcement agencies'
