COMMITTEE AMENDMENT "A" to H.P. 1472, L.D. 2191, "An Act to Establish a Biennial Inspection System for Vehicle Rental Companies"

Amend the bill in section 1 in subsection 1-A in paragraph A in the first line (page 1, line 6 in L.D.) by striking out the following: "1,000" and inserting the following: '700'

Amend the bill by inserting after section 1 the following:

'Sec. 2. 29-A MRSA §1766, sub-§3, as amended by PL 2011, c. 191, §2, is further amended to read:

3. Fee. Except as provided in subsection 3-A and 3-B, stickers are furnished by the Chief of the State Police at \$2.50 each.

Sec. 3. 29-A MRSA §1766, sub-§3-B is enacted to read:

3-B. Fee for business that rents noncommercial motor vehicles. Stickers furnished by the Chief of the State Police to a business that rents noncommercial vehicles pursuant to section 1751, subsection 1-A are 2 times the fee for stickers under subsection 3.

Sec. 4. Effective date. This Act takes effect January 1, 2027.'

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

SUMMARY

This amendment does the following.

1. It reduces from 1,000 to 700 the minimum number of motor vehicles a business that rents noncommercial motor vehicles must have registered in Maine to be issued a 2-year certificate of inspection for each vehicle.

2. It sets the fee for inspection stickers issued to a business that rents noncommercial motor vehicles at 2 times the fee for inspection stickers issued annually to persons who are not new motor vehicle dealers.
