3 This bill is submitted by the Joint Standing Committee on State and Local Government
4 pursuant to its responsibility under the Maine Revised Statutes, Title 5, section 12006,
5 subsection 2 to consider whether to eliminate boards and commissions that either failed to
6 file the required annual report in both 2024 and 2025 or reported inactivity during that 2-
7 year period. The committee has not taken a position on the substance of the bill. By
8 reporting out the bill, the committee is not suggesting and does not intend to suggest that it
9 agrees or disagrees with any aspect of the bill. The committee is reporting out the bill for
10 the sole purpose of having a bill printed that can be referred to the committee for an
11 appropriate public hearing and subsequent processing in the normal course. The committee
12 is taking this action to ensure clarity and transparency in the legislative review of the
13 proposals contained in the bill.
