STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SIXTY-EIGHT.

AN ACT to authorize apothecaries and druggists to sell distilled and fermented liquors for certain purposes.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Section 1. The selectmen of any town and the
- 2 mayor and aldermen of any city may authorize apoth-
- 3 ecaries and druggists residing and doing business
- 4 within such city or town, to sell distilled or fermented
- 5 liquors upon the written prescriptions of any physician
- 6 in regular practice, other than the person so author-.
- 7 ized, to be used for medicinal purposes only.
 - Sect. 2. The authority given to any apothecary or
- 2 druggist, by such municipal officers, to sell distilled
- 3 and fermented liquors in manner as aforesaid, shall be

- 4 in writing and shall continue in force one year from
- 5 its date unless sooner revoked; but the same may be
- 6 revoked by said officers whenever they shall be satis-
- 7 fied that there is sufficient cause for such revocation.
 - Sect. 3. Such authority shall not be given to any
- 2 apothecary or druggist, by the municipal officers of
- 3 any city or town, until he shall have executed and
- 4 delivered to said officers a bond, with two good and
- 5 sufficient sureties, in the sum of one thousand dollars,
- 6 in substance as follows:
- 7 Know all men that we —— as principals and ——
- 8 as sureties, are holden and stand firmly bound to the
- 9 inhabitants of the town of ---- (or city, as the case
- 10 may be,) in the sum of one thousand dollars, to be
- 11 paid them, to which payment we bind ourselves, our
- 12 heirs, executors and administrators, firmly by these
- 13 presents.
- 14 Sealed with our seals, and dated this day of —
- 15 A. D. ——.
- 16 The condition of this obligation is such that where-
- 17 as the above bounden —— has been duly authorized
- 18 to sell distilled and fermented liquors in said town (or
- 19 city) for medicinal purposes only, for the term of one
- 20 year from this date, pursuant to an act entitled an act
- 21 to authorize apothecaries and druggists to sell distilled

- 22 and fermented liquors for certain purposes, passed by
- 23 the legislature of eighteen hundred and sixty-eight.
- 24 Now if the said —— shall in all respects conform to
- 25 the provisions of said act, and to such regulations as
- 26 shall be from time to time established by the select-
- 27 men of said town (or mayor and aldermen of said city)
- 28 relating to the sale of such liquors, then this obliga-
- 29 tion to be void, otherwise to remain in full force.
 - Sect. 4. Apothecaries and druggists so authorized
 - 2 shall sell pure liquors only, either separate or as com-
 - 3 pounded with other medicines; and they shall preserve
 - 4 in a book kept for that purpose, and at all times open
 - 5 to the inspection of the public, each prescription filled
 - 6 by them with distilled or fermented liquors, with the
 - 7 name of the physician giving it, and the name of the
 - 8 person to whom it is given; and the municipal officers
 - 9 of any city or town may prohibit any person so au-
- 10 thorized from selling distilled or fermented liquors
- 11 upon the prescriptions of any physician who they have
- 12 good reason to believe has knowingly at any time pre-
- 13 scribed such liquors for any other than medicinal pur-
- 14 poses.
 - SECT. 5. For the purposes of this act, apothecaries
 - 2 and druggists shall be understood to mean those per-
 - 3 sons only whose principal business is the preparation

- 4 and dispensing of medicines, and the sale of drugs;
- 5 and whose education and experience have been such
- 6 as to fit them for properly conducting that business.

SECT. 6. This act shall take effect when approved.
