STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SIXTY-NINE.

AN ACT to incorporate the Bradley and Oldtown Bridge Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. Samuel F. Harrison, W. J. Parlin, Sam-

- 2 uel Bullen, G. F. Barton, J. B. McIntosh, A. C. Bean,
- 3 C. H. Miller, with their associates and successors, are
- 4 hereby constituted a body corporate by the name of
- 5 the Bradley and Oldtown Bridge Company, for the
- 6 purpose of erecting and keeping in repair a bridge
- 7 over the Penobscot river from Great Works in Bradley
- 8 to West Great Works in Oldtown, and said corporation
- 9 shall have power to purchase and hold such personal
- 10 and real estate as may be necessary to carry said object
- 11 into effect, to prosecute and defend suits at law, to

- 12 have and use a common seal, to make by-laws for the
- 13 management of their concerns not repugnant to the
- 14 laws of the state, and to have and enjoy all the powers
- 15 and privileges incident to or usually granted to similar
- 16 corporations.
 - Sect. 2. Said bridge shall be erected across the
 - 2 Penobscot river at or near Bradley village in the
 - 3 county of Penobscot, shall be constructed of good
 - 4 materials of a suitable hight from the water, and not
 - 5 less than twenty feet wide, and railings for safety of
 - 6 passengers, and sufficient passage ways shall be left
 - 7 for the passage of rafts and logs and timber.
 - Sect. 3. A toll is hereby granted and established
 - 2 for the benefit of said corporation, according to the
 - 3 rates following, to wit:--for every foot passenger, one
 - 4 cent; for each horse and rider, six cents; for each
 - 5 sleigh, sled, cart or wagon drawn by one beast, ten
 - 6 cents; for each sleigh, sled or wagon drawn by two
 - 7 beasts, fifteen cents; for each coach, chariot, phaeton
 - 8 or curricle, twenty cents; for droves of neat cattle,
 - 9 two cents each; for sheep and swine, ten cents a
- 10 dozen. No additional toll shall be charged for persons
- 11 actually travelling in any of said vehicles; and said
- 12 tolls may be commuted by this corporation with any
- 13 person or corporation, by taking of him or them a sum
- 14 certain for a specified time instead there is persons

- 15 going or returning from military duty; persons going
- 16 to or returning from any place of public worship on
- 17 the Sabbath, and persons going to or returning from
- 18 funerals, shall be allowed to pass free of tolls.
 - Sect. 4. At the place of collecting tolls said corpo-
 - 2 ration shall keep constantly exposed to view a board
 - 3 or sign, upon which shall be plainly printed the rates
 - 4 of tolls; and whenever the toll-gatherer shall be absent
 - 5 from the toll-house the gates shall be left open and the
 - 6 bridge toll free; and said toll shall commence on the
 - 7 day when said bridge is first opened for passengers.
 - Sect. 5. If said corporation shall neglect or refuse
 - 2 for the space of five years from the passage of this act
 - 3 to build and complete said bridge, then this act shall
 - 4 be void and of no effect.
 - Sect. 6. Said corporation may lay rails over said
 - 2 bridge, so that the same may if need be, be used as a
 - 3 railway for transporting passengers and freight, subject
 - 4 to the general laws of the state relating to railroads.
 - Sect. 7. The towns of Bradley and Oldtown are
 - 2 hereby authorized to exempt by vote of the inhahit-
 - 3 ants, the property of said corporation and the shares
 - 4 thereof from taxation for a period of ten years.
 - SECT. 8. Any three named in the first section may
 - 2 call the first meeting of the corporation by posting up
 - 3 notice of the time, purpose and place of meeting, in

- 4 two public and conspicuous places in the towns of
- 6 Bradley and Oldtown fourteen days before the time
- 7 of said meeting.

SECT. 9. This act shall take effect upon its ap-2 proval.
