STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SIXTY-NINE.

AN ACT to change the place of holding the February term of the supreme judicial court in the county of Aroostook.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECTION 1. The term of the supreme judicial court
2 which is now required to be holden at Houlton, in
3 and for the county of Aroostook, on the last Tuesday
4 of February annually, shall hereafter be holden at
5 Caribou in said county.

SECT. 2. The previous section of this act shall be
2 wholly void and of no effect, unless the town of
3 Caribou aforesaid, shall on or before the twentieth day
4 of December, eighteen hundred and sixty-nine, with-
5 out expense to the said county of Aroostook, provide

6 a suitable court room and other accommodations for
7 the said court and officers, and also a safe and con-
8 venient place in said town of Caribou in said county
9 wherein to secure persons charged with crimes or
10 misdemeanors, during each session of the court, to be
11 holden as aforesaid, to the acceptance of a majority of
12 the board of county commissioners for said county of
13 Aroostook, and shall execute and deliver to them a
14 sufficient lease or other instrument to secure the use
15 thereof to the said county for the purposes aforesaid,
16 for and during such time as said term shall be holden
17 at said Caribou.

SECT. 3. The said commissioners shall cause a record
2 of such instrument to be made by their clerk, and
3 shall, as soon thereafter as may be, cause a notice of
4 the fact that such provision has been made, and
5 of its acceptance by them, to be published in the
6 regular issues of The Sunrise and the Houlton Times,
7 two newspapers published in said county of Aroostook,
8 until the last Tuesday of February aforesaid; and the
9 said town of Caribou is hereby authorized to assess and
10 raise a sufficient sum or sums for the purposes of pro-
11 viding said accommodations for the said courts and
12 keeping of prisoners.

SECT. 4. This act shall take effect from and after its
2 approval.
