STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SIXTY-NINE.

AN ACT to incorporate the Royalls River Water Power Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. Ansel L. Loring, Charles J. Little,

- 2 Sylvanus C. Blanchard, Richard O. Conant, Barnabas
- 3 Freeman, Charles D. Brown, Elias B. Denison, their
- 4 associates, successors and assigns, are hereby incorpo-
- 5 rated and made a body politic by the name of The
- 6 Royalls River Water Power Company, for the pur-
- 7 pose of increasing and improving the water power of
- 8 Royalls river in the county of Cumberland; and to
- 9 this end they are hereby authorized to purchase and
- 19 hold such personal and real estate as may be neces-
- 20 sary, not exceeding in value the sum of ten thousand
- 21 dollars, for the purpose of erecting and maintaining

22 dams across Royalls river, at or near the outlets of 23 Sabbath Day or Seabody and Lilley ponds, in New 24 Gloucester, and such other dams or canals on said 25 Royalls river and its branches as they may deem 26 necessary; subject only to such damages as are pro-27 vided by the statutes of the state in the case of mill 28 owners for flowage.

The sums expended in such erections and 2 improvements as may be made by this corporation, 3 shall be borne by the several mill owners on said river 4 benefitted thereby, in such proportion as they may 5 severally agree to bear the same. In the event of 6 disagreement the share of each may be determined by 7 arbitrators mutually chosen, or by the county com-8 missioners, as the corporation may determine. 9 event of the neglect or refusal of any party benefitted 10 by the improvements of this corporation, to pay his or 11 their proportionate share thereof for the space of three 12 months after the same is due and demanded by the 13 corporation, he or they shall be liable to pay interest 14 thereon at and after the rate of twelve per cent. per 15 annum until the same is paid; and said company shall 16 hold a lien on the property of such delinquent so 17 benefitted, until such share and interest is discharged, 18 which lien may be enforced by an action of debt.

Sect. 3. The corporation may enter upon and hold 2 such land as may be necessary to build and maintain 3 said dams and make said improvements, and take all 4 the materials, rocks, earth or timber, which may be 5 needed for such building, reconstruction or repairs, 6 and shall pay to the owners of such materials taken 7 the fair and just value thereof; and in case of disa-8 greement as to the value, any person whose property 9 has been so taken may apply to the county commis-10 sioners of the county in which such materials were 11 taken, to fix said value, under the same mode of pro-12 ceeding and with the same remedies as are provided 13 by law in cases of flowage.

SECT. 4. In the choice of officers and all transactions of business of the corporation at its first meeting, the owners of each power on said river shall be entitled to one vote. At subsequent meetings, the number of votes to which each power shall be entitled, shall be in proportion to the share of the expenditure for which said power is liable. No sale or alienation of the company's property shall be made without a unanimous vote of the corporation, at a meeting specially called for such purpose. The first meeting of said company may be called by any one of the persons named in this act, by publishing in any daily newspaper printed in Portland, a notice thereof, setting forth the time,

- 14 place and purpose of said meeting, for three days in
- 15 succession, the last publication thereof to be at least
- 16 five days preceding the day of said meeting.

SECT. 5. This act shall take effect when approved.
