## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SIXTY-NINE.

AN ACT for the promotion of medical science.

[As amended by the House.]

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section. The overseers of the poor of any city or

- 2 town containing not less than five thousand inhabit-
- 3 ants, by the census of the United States then next
- 4 preceding; the warden of the state prison, and the
- 5 keepers of the several jails in this state, may give per-
- 6 mission to any physician or surgeon, (preference being
- 7 given to instructors and medical schools established by
- 8 law,) upon his request, to take the bodies of such per-
- 9 sons dying in their city or town, or in the state prison,
- 10 or in a jail, as are required to be buried at the public

- 11 expense, to be by him used within the state for the 12 advancement of anatomical science.
  - Sect. 2. Every person before receiving any such 2 body, shall give bonds to the officer surrendering it, 3 with sufficient sureties, that such body shall be used 4 only in this state, and for the promotion of anatomical 5 science, and in such a manner as in no event to out-6 rage the public; and that after the use allowed by

7 law, the remains thereof shall be decently buried.

- SECT. 3. No such body shall be surrendered, if the 2 deceased, at any time while in the care of the person 3 or institution, in whose custody he died, requested to 4 be buried; or if within three days after his death, any 5 friend or kindred to the deceased, asks to have the 6 body buried; or if the deceased was a traveller or 7 stranger who suddenly died. In other cases described 8 in section one, it shall be the duty of the officer or 9 officers aforesaid, to surrender such body on request, 10 as in that section provided, upon receipt of the bond 11 provided for in section two.
  - Sect. 4. Any person knowingly surrendering, or 2 knowingly receiving any such body for anatomical 3 purposes, contrary to the provisions of this act, shall 4 be punished as provided in section twenty-six of 5 chapter one hundred and twenty-four of the revised 6 statutes. The provisions of this bill shall not apply to

- 7 any person dying in the poor-houses of any city or
- 8 town containing five thousand inhabitants who are
- 9 chargeable to any town containing less than five thou-
- 10 sand inhabitants.
