## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SEVENTY.

AN ACT in addition to an act to incorporate the Portland and Rutland Railroad Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. The Portland and Rutland Railroad

- 2 Company, incorporated by act approved March sixth,
- 3 eighteen hundred and sixty-eight, is hereby allowed
- 4 to take the name of the Portland, Rutland, Oswego
- 5 and Chicago Railway Company, by vote of the stock-
- 6 holders thereof, at the time of the organization of the
- 7 company, or at any meeting of the stockholders duly
- 8 called for such purpose.
- SECT. 2. Said railroad company shall have authority
- 2 to extend its line to Chicago, through the states of
- 3 New Hampshire, Vermont, New York, Michigan,
- 4 Indiana and Illinois, in case authority therefor is
- 5 granted by said states, or either of them; with the
- 6 further right to extend its line across the peninsula of  $\cdot$

- 7 Ontario, in the Dominion of Canada, from the Niagara
- 8 river to St. Clair river, in case authority therefor is
- 9 granted by the parliament of Canada or the Province
- 10 of Ontario; with the further right to unite its line
- 11 with the line of any other railroad company in either
- 12 of said states or said Province of Ontario, and to issue
- 13 its bonds to aid the construction of any other connect-
- 14 ing line of railway in either of said states or said
- 15 Province of Ontario, or lease or purchase any connect-
- 16 ing line in this state or in either of said states or said
- 17 Province of Ontario, or sell its line and all its rights
- 18 and franchises to any other railroad company in either
- 19 of said states or said Province of Ontario, so as best
- 20 to form a connecting line of railway from Portland,
- 21 Maine, to Chicago, in the State of Illinois.
  - SECT. 3. Said company is hereby authorized to in-
  - 2 crease its capital stock to an amount sufficient to
  - 3 complete said line from Portland to Chicago, as the
  - 4 different sections thereof are from time to time com-
  - 5 pleted, but not to exceed the actual cost of the line,
  - 6 or more than three hundred thousand shares.
