STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SEVENTY-ONE.

AN ACT in aid of free high schools.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Whenever any city, town or towns, shall

2 establish and maintain a suitable free high school for

3 such city, town or towns, and shall annually make

4 special appropriation, by tax or otherwise, for the

5 same, the state by this act covenants to appropriate

6 annually in aid of said free high school, not already

7 provided for by state aid, a sum equal to the amount

8 raised and actually paid by each city or town, for the

9 like purpose; in no case to exceed five hundred dol-

10 lars on the part of the state; said appropriation to be

11 paid by the state treasurer, on or after November first

12 of each year, upon proper certification by the governor

13 and council, as provided in section four of this act.

- Sect. 2. It shall be the duty of the town, or school
- 2 district, in which said free high school shall be located,
- 3 to furnish at the expense of said town, or district, a
- 4 suitable building and equipments for said school.
 - Sect. 3. The course of study in said high school
- 2 shall embrace the ordinary academic studies, and
- 3 especially the natural sciences in their application to
- 4 mechanics, manufactures and agriculture.
- Sect. 4. Prior to the making, or paying, of any
- 2 appropriation by the state in aid of such school, satis-
- 3 factory evidence shall be furnished to the state super-
- 4 intendent of common schools, and by this officer to the
- 5 governor and council, that the city, or town, asking
- 6 aid, has complied with the conditions required in sec-
- 7 tions one and two of this act; and a certificate thereof
- 8 shall be issued by the governor and council for the
- 9 benefit of the city, or town, asking such aid.
- Sect. 5. Cities, towns and school districts are here-
- 2 by empowered to appropriate a portion of their school
- 3 money to sustain said free high school, as indicated in
- 4 this act, in addition to the special appropriation re-
- 5 quired by section one.
 - SECT. 6. The free high school contemplated by this
- 2 act shall be free to all youth in the town on such con-
- 3 ditions of attainments, or scholarship, as shall be fixed
- 4 by the superintending school committee of that town;

- 5 and the same school may be open to youth from other
- 6 towns upon the same conditions of scholarship, and at
- 7 such rates of tuition as the superintending school com-
- 8 mittee may determine.
