STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SEVENTY-ONE.

AN ACT giving additional powers to the railroad commissioners.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. The railroad commissioners, upon petition

- 2 of responsible parties, representing that the public
- 3 convenience and necessity require the erection and
- 4 maintenance of a depot for freight and passengers, or
- 5 a passenger station, on the line of any railroad, after
- 6 fourteen days notice, by copy of said petition upon
- 7 such corporation, and by publishing said petition with
- 8 the order of said commissioners thereon, in such pub-
- 9 lic newspaper as shall be designated in said order, two
- 10 weeks successively, the last publication to be prior to
- 11 the time fixed for said hearing, shall hear the parties
- 12 and determine whether the prayer of the petitioners

- 13 shall be granted; and if such prayer is granted, shall
- 14 determine at what place or places a depot or station
- 15 shall be erected, or maintained if erected, and whether
- 16 for passengers or for passengers and freight.
 - Sect. 2. It shall be the duty of said commissioners
 - 2 to designate the site and what kind of building shall
 - 3 be erected and maintained, as the case may seem to
 - 4 demand, and the time in which said corporation shall
 - 5 comply with said order.
 - Sect. 3. If said railroad corporation refuse or neg-
 - 2 lect to comply with the order of said commissioners,
 - 3 within the time prescribed therein, said commissioners
 - 4 shall enforce a compliance as provided in section
 - 5 seventy-five of chapter fifty-one of the revised statutes
 - 6 of eighteen hundred and seventy-one, in relation to
 - 7 making repairs of railroads.
 - Sect. 4. In all cases heard before commissioners
 - 2 under the provisions of this act, the expenses and costs
 - 3 attending the same, including the compensation of the
 - 4 commissioners, shall be paid by the railroad corporation
 - 5 against whom the complaint is made, if the prayer of
 - 6 petitioners is granted, and in case the prayer of the
 - 7 petitioners is denied, such costs and compensation shall
 - 8 be paid by the petitioners. If the party or parties
 - 9 against whom costs are adjudged as aforesaid, shall re-
- 10 fuse or neglect to pay the same within thirty days

- 11 after such adjudication, upon complaint for such costs
- 12 made by said commissioners to any one of the justices
- 13 of the supreme judicial court, such justice may cause
- 14 execution to issue therefor.
