## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SEVENTY-ONE.

AN ACT to repeal the acts consolidated in the revised statutes of the year one thousand eight hundred and seventy-one.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. The public acts passed during the years 2 hereinafter named and herein designated are repealed, 3 except so far as they are preserved or accepted in the 4 following sections; but no other acts are hereby 5 repealed:

6 1857. All the chapters of the revised statutes of 7 eighteen hundred and fifty-seven, numbered one to 8 one hundred and forty-three, inclusive.

9 1858. Chapters numbered one to fifty-four, inclu-10 sive, except chapters nine, twenty, twenty-two, forty-11 nine and fifty.

12 1859. Chapters numbered fifty-five to one hundred
13 and twenty-four, inclusive, except chapters fifty-seven,
14 sixty-five, eighty-three, eighty-eight, ninety, one hun15 dred and nineteen, and one hundred and twenty-two.
16 1860. Chapters numbered one hundred and twenty-

17 five to one hundred and ninety-three, inclusive, except18 chapters one hundred and seventy-two and one hun-19 dred and eighty-one.

20 1861. Chapters numbered one to sixty-four, in-21 clusive, except chapters twenty, forty-nine, sixty-one 22 and sixty-three.

23 1862. Chapters numbered sixty-five to one hun-24 dred and fifty-five, inclusive, except chapters seventy-25 one, eighty-three, one hundred and six, one hundred 26 and eight, one hundred and twenty-seven, one hun-27 dred and twenty-eight, one hundred and thirty-nine, 28 one hundred and forty-two, one hundred and forty-29 three, one hundred and fifty-three and one hundred 30 and fifty-four.

31 1863. Chapters numbered one hundred and fifty-32 six to two hundred and eighteen, inclusive, except 33 chapters one hundred and fifty-six, one hundred and 34 fifty-seven, one hundred and fifty-eight, one hundred 35 and seventy-eight, one hundred and seventy-nine, one 36 hundred and eighty-two, one hundred and eighty-

41 1864. Chapters numbered two hundred and nine-42 teen to two hundred and eighty-one, inclusive, except 43 chapters two hundred and nineteen, two hundred and 44 twenty, two hundred and twenty-one, two hundred 45 and twenty-seven, section three of chapter two hun-46 dred and fifty-four, chapters two hundred and fifty-47 five, two hundred and fifty-seven, two hundred and 48 fifty-nine, two hundred and sixty-six, two hundred 49 and sixty-nine and two hundred and seventy-three.

50 1865. Chapters numbered two hundred and eighty-51 two to three hundred and thirty-five, inclusive, except 52 chapters two hundred and eighty-two, two hundred 53 and eighty-five, two hundred and ninety-eight, three 54 hundred and three, three hundred and seven, three 55 hundred and eleven, three hundred and seventeen, 56 three hundred and twenty-eight and three hundred 57 and thirty-one.

58 1866. Chapters numbered one to fifty-nine, inclu-59 sive, except chapters one, seventeen and forty-eight.

60 1867. Chapters numbered sixty to one hundred 61 and thirty-three, inclusive, except chapters sixty,

65 1868. Chapters numbered one hundred and fifty-66 nine to two hundred and twenty-six, inclusive, except 67 chapters one hundred and seventy, one hundred and 68 seventy-three, one hundred and ninety-five and two 69 hundred and twenty-five.

Chapters numbered one to seventy-six, in-701869. 71 clusive, except chapters one, sixteen, nineteen, thirty, 72 section three of chapter thirty-one, and chapter forty. 73Chapters numbered seventy-seven to one 1870.74 hundred and seventy, inclusive, except chapters eighty-75 four, eighty-nine, section nineteen of chapter one hun-76 dred and twenty-one, section seven. of chapter one 77 hundred and twenty-five, section two of chapter one 78 hundred and thirty-one, chapters one hundred and 79 forty-five, one hundred and fifty-seven, section two of 80 chapter one hundred and fifty-eight, chapter one hun-81 dred and sixty-nine.

SECT. 2. The repeal of the acts aforesaid does not 2 revive any of the acts repealed by them. Acts of 3 incorporation declared to be public acts, are not re-4 pealed. The acts declared to be repealed remain in 5 force for the trial and punishment of all past violations

6 of them; and for the recovery of penalties or forfeit-7 ures already incurred; and for the preservation of all 8 rights and their remedies existing by virtue of them; 9 and so far as they apply to any office, trust, judicial 10 proceeding, right, contract, limitation, or event, already 11 affected by them.

SECT. 3. This act shall take effect from and after 2 the first day of May, eighteen hundred and seventy-3 one.
